Hiltonians were chilled on January 31, both by the 19° weather and by news of a prisoner's escape from Trenton Psychiatric Hospital. The Google group was abuzz with updates and reports gleaned from the seemingly random official notifications about the escape. Crisis was averted, but the situation itself was a stark reminder of the "in the dark" nature of our relationship with TPH.

Mike Ranallo volunteered to reach out to TPH to set up a meeting to voice resident concerns and discuss ways to strengthen ties between the hospital and Hiltonia. Shortly thereafter, Mike, Paul Perez, and Dennis Wendell traveled to TPH to meet with Michelle Senni, Public Information Officer, and Fred Conti, Director of Public Safety and Security. The meeting was a positive experience.

TPH is very interested in strengthening ties with Hiltonia, and the group discussed various ways of doing so. Beyond improving notifications, TPH is willing to have representatives attend a neighborhood meeting to provide information and answer questions. Other possibilities include arranging TPH tours and encouraging attendance at monthly TPH board meetings. Dennis is coordinating with Michelle on details for an April special association meeting—stay tuned for details!

## County to Host March 30 Event

TRENTON—The Mercer County Improvement Authority (MCIA) will host a Household Hazardous Waste and Electronic Waste Disposal Day on Saturday, March 30, for County residents who would like to recycle common residential chemical wastes or used electronics.

The event will take place from 8 a.m. to 2 p.m. at the <u>John T. Dempster Fire School at 350 Lawrence Station Road in Lawrence</u>, rain or shine. While no registration is necessary, the event is open to Mercer County residents only, and attendees will need to show proof of residency, such as a driver's license. ## Restore Trenton! A Grant Program

We learned about this grant program from a 2018 Hilltone article and decided to apply to help support repairs to our slate roof. We turned to our fellow Hiltonians for contractor recommendations—thanks, Candice Brearley and Mike Ranallo!—and soon had the pleasure of meeting Don Still, expert on all things slate. A third-generation slate man, Don lost no time assessing what our roof needed and what it would take to carry out the repairs. We submitted our application and then began the long wait. A couple of months later, we arrived home after a particularly hectic workday to a letter notifying us we'd been approved for a grant. The entire process that followed went smoothly, and we celebrated its conclusion by attending the annual Stop the Wrecking Ball fundraiser.

The Trenton Historical Society website provides a lot of information about the program (<a href="http://trentonhistory.org/restore-trenton-historic-property-rehabilitation-grant-program/">http://trentonhistory.org/restore-trenton-historic-property-rehabilitation-grant-program/</a>). A few highlights: the property must be a residential property located within Trenton city limits and be at least 50 years old. Preference is given to properties owned by Trenton residents and located in a historic district or those listed as an individual property on city, state, or national registers of historic places. Funding is limited to exterior projects and may include, but is not limited to, rehabilitation, restoration, and major repairs (but not ongoing maintenance) of architectural details and features. Awards range between \$500 to \$3000, and applicants are responsible for complying with all city, state, and federal requirements for permits and approval. Projects must be completed within 12 months of the award.

If we hadn't learned about this program, we might not have paid the necessary attention to our roof before the repairs it needed became major and costly. We consider ourselves fortunate to be in a community where residents are so willing to share information and collectively improve our neighborhood. If you have a home and project that meet the grant's requirements, we absolutely recommend looking into the program!

## Rules and Regs: Property Ordinances

Below is a list of ordinances that are important responsibilities of residents and homeowners in Hiltonia. Please observe them, since the city inspectors will issue citations for violations if they are noticed or reported. These ordinances help preserve the appearance of our neighborhood and the value of our properties.

#### **Vehicles**

- 1. Vehicles cannot be on front/side yards (grass), unless in an enclosed garage or behind the front building line.
- 2. Boats (except for canoes and boats under 20 feet in length) cannot be stored in the open for over one week, except within the rear yard at least 3 feet from any adjoining property line.
- 3. No recreational vehicle or automobile trailer can be stored in the open for over one week except in the rear yard, at least 3 feet from any adjoining property line.
- 4. Vehicles that are used for business purposes may not be parked on any private property between the hours of 8:00 PM and 6:00 AM except in garages or behind the front building line.
- 5. Inoperable motor vehicles should not be stored on private property for more than three weeks, except in closed garages.

#### **Fences**

- 1. Houses on corner lots have **two** front yards. So the rules about front yards apply to both.
- 2. Fences (or masonry walls) are not permitted in front yards in front of the building line.
- 3. Fences (and masonry walls) that are behind the front building line must comply with the following:
  - a. Cannot be more than 6 feet in height
  - b. No barbed or razor wire can be used
  - c. Some fences that were in place when the ordinances were passed have been grandfathered.

## Tara Westover's Grandma-over-in-town's Chocolate Chip Pumpkin Cookies

Prep Time: 20 minutes

The author's grandmother's recipe was posted for book clubs and readers to enjoy. Terri's notes: This is a weird recipe, but the unique flavors of these cake-like cookies were a hit with some of us!

#### **Ingredients:**

- 5 cups flour
- 2 teaspoons baking powder
- 2 teaspoons baking soda
- 2 teaspoons salt
- 2 teaspoons ground nutmeg
- 2 teaspoons ground cinnamon
- 2 teaspoons ground allspice
- 1 cup butter
- 3 cups sugar
- 3 ½ cups canned pumpkin

2 egas

2 teaspoons vanilla extract

Cook Time: 10 minutes

2 cups semi-sweet chocolate morsels

#### Instructions:

- 1. Heat oven to 375° F.
- 2. Combine flour, baking powder, baking soda, and spices in a medium bowl. In a large mixing bowl, cream butter and sugar together until well blended. Add pumpkin, egg, and vanilla. Mix until combined. Stir in flour mixture. Fold in chocolate morsels. Drop by teaspoons onto ungreased cookie sheet.
- 3. Bake 11-12 minutes or until edges are firm. Cool on baking sheets for 2 minutes; remove to wire racks to cool completely.

## Worthy Projects By Jacques & Maureen Lebel

As readers of the last few issues of The Hilltone are well aware, Hiltonia's 2018 Worthy Projects effort succeeded in assisting two local non-profits to provide their services to the residents of Trenton. The Association agreed to provide matching funds of up to \$250 for each project (The Trenton Children' Chorus and Passage Theatre Company) to be used in matching donations from Hiltonia residents on a \$1 to \$1 basis. Thanks to the largess of Hiltonia residents, the projects received \$683.00 and \$643.00 respectively.
