TWW Lead Line Replacement Program By Paulette Ayres

At the August 8th TCCA (Trenton Council of Civic Associations) meeting, attendees were given an update on the Lead Line Replacement program by Michael Walker, Management Specialist at TWW.

The program is designed to replace lines from the curb to your home. Commercial properties are not included in the replacement program. If the lines are copper or plastic, you do not have to participate in the program. If the lines are lead or galvanized steel pipes your home is eligible for replacement. The water meter will also be replaced.

The city anticipates replacing pipes to 2,600 homes in the initial phase. Currently the city has less than 2,600 homes signed up for the program. As some residents don't have access to the internet, the city has contracted with a non-profit organization to canvas neighborhoods in order to make residents aware of the program.

The cost of the lead line replacement is \$1,000.00. Homeowners can pay when the work is completed or it can be paid over five years as a special assessment through the tax collector. The estimated cost is approximately \$16.60 per month.

A non-profit organization, Clean Water Action, is offering free tests for lead in homeowners water line in conjunction with the N.J. Environmental Justice Association located at 315 West State Street, Trenton.

Lead line replacement registration forms previously sent out to households across the city can be completed and mailed in. However, you can log in to the internet site to complete the registration and/or check the status of your registration by entering your account number. The site is <https://www.twwleadprogram.com>.

Recycling Reminders

Since 1987, New Jersey state law has mandated recycling, but Mercer County residents can't seem to figure out what

is recyclable and what isn't. The result has been increasingly contaminated containers and huge increases in recycling costs.

Because the biggest contributors to contamination of the recycling stream are **plastic bags and pizza boxes**, Robbinsville and the Mercer County Improvement Authority are focusing on them in campaigns to reeducate consumers on the how-to's of recycling.

Plastic bags and any items inside them go directly into the trash at the processing plant. "It could be 100 percent clean recycling, but it is not opened at the facility," Dan Napoleon, director of environmental programs at the Mercer County Improvement Authority, says. **Plastic bags** that make their way to the sorting line can jam up the sorting machinery and must be removed by hand, which increases costs. **Pizza boxes** are rejected because any oil that has seeped into the cardboard will remain part of the paper fibers when they get to the pulping process.

The Mercer County Improvement Authority is planning a reeducation campaign that will also culminate in increased enforcement. It will include a one-page piece to residents and will use print and social media and radio.

The campaign will continue over several months so that residents have time to start changing their recycling behavior. "Our ultimate goal is to say, after maybe Jan. 1st **'Your bucket won't be collected if you have plastic bags and pizza boxes.'**"

So residents should take heed of important advice from recycling professionals: **"When in doubt, throw it out."**

Recycle Your Car Seats—Hurry the Deadline is Near!

Trenton's TerraCycle and Walmart are joining forces to launch the nation's largest car seat recycling event in nearly 4,000 Walmart stores across the country.

The first-ever Walmart Car Seat Recycling Event will take place **Sept. 16th -30th**, in celebration of National Baby Safety Month. Customers can trade in used car seats at the Service desk in any participating Walmart store and receive a \$30 Walmart gift card that can be used in store or online to buy items for their baby. All car seats collected in this program will be recycled through TerraCycle, and each component will be diverted from the landfill.

Trenton Psychiatric Hospital Meeting

As part of our continuing effort to strengthen ties with TPH, I made arrangements for a meeting on site with all interested Hiltonians. On the evening of July 15, a group of us made our way to TPH to voice concerns and gather information. We met with key staff in the boardroom and, as in the smaller meeting earlier this year, TPH actively listened to our concerns and addressed our questions.

First and foremost, we wanted to know why we hadn't been alerted to a recent patient escape. We learned that notification rules require that TPH alert Ewing and Trenton police departments. From there, information dissemination is in the hands of those departments, who have their own processes and rules around notifying residents.

Jeannie Weakliem and I brought the issue to the next CPAC meeting, and there has been some progress. The very next escape event resulted in a reverse 911 call from Trenton PD. It was somewhat late (most of us had already learned the news via Ewing contacts and our own Google group) and there was no follow-up call with the all-clear. We're continuing to raise the issue via CPAC and direct communication with our community officer.

Additional concerns included speeding by TPH employees along the Hiltonia stretch of Stuyvesant (they will remind staff of 25 MPH speed limit); noise from the Travers Complex, the cottages along Cornwall (call 24/7 with any complaints, use the main switchboard after hours); decreased/missing razor-wire (this is a feature only in the correctional facility/CRAF, and TPH fencing is well maintained).

Hiltonians also asked about publicizing the greenhouse, which TPH supports. Kathi plans to draft an article for the *Hilltone*, which must be run by TPH before publication. TPH encourages positive interactions, and opportunities exist for anyone willing and able to participate in auxiliary efforts (donations for patients about to be discharged, volunteers for special projects, etc.). Economic Development Update

The State offered money for businesses to fix up their buildings, creating a better consumer experience and, in some cases, creating new jobs. In the two years that the program ran (it ended June 2019), the Division of Economic Development worked to spend every bit of the NJEDA money allocated to Trenton, recruiting and vetting the following businesses who were eventually approved: the African American Chamber of Commerce, 302 East State Street, 28 South Warren, the downtown Dunkin Donuts, 1100 Dentist on Broad Street, Greater Trenton, Peter's Place, Capitol

Smiles Dentist, and Karl Weidel Insurance. Two more are finishing up approval.

The State also offered money to pay 15% of the rent for businesses locating in Trenton. The Division of Economic Development worked to leverage this for business attraction. Businesses who took advantage of this so far include the Mill Hill Pharmacy, Haleemah's Islamic Fashion, Arlee's Raw Blend, and New Jersey Utilities Association.



Trenton Corrugated Products transferred ownership and will be remaining open in Trenton. Fed Em Up Grill (312 East State Street) had its grand opening on July 20th. New businesses include Cooper's Riverview (the old Kat Man Du) and Halal Brothers (503 Hamilton Ave).

There is a lot of work being done on Warren Street. Renovations at 110 South Warren (the former dry cleaners), 113 South Warren (the former Bowl and the coming empanada place), and 17 East Front (the former Settimo Cielo) have begun. The sign for Copacetic (the former Café Ole) went up recently.

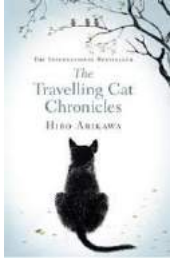

Hiltonia readers gathered at Pat Flores's home on June 23rd to enjoy Japanese-themed delicacies and discuss Hiro Arikawa's *The Travelling Cat Chronicles*. What a treat it was to kick off the evening with a sake tasting. Everyone appreciated Pat's efforts to introduce us to the nuances of flavor associated with temperature.



The kitchen island was soon overtaken with terrific dishes, including sobo salad and noodles, potstickers with delectable dipping sauces, grilled teriyaki pork roast with Vern's tangy peanut sauce, vegetable tempura, edamame, assorted Japanese desserts (which Terri shamefully admitted to purchasing online), and perfectly presented Japanese tea.

Garden Center at Trenton Psychiatric Hospital

Did you know that there is a little gem of a place not too far from our neighborhood? You can reach the greenhouses from Sullivan Way just off of Hilvista Boulevard. Please stop at the guard house first.

The Newleaf Gardeners Program at Trenton Psychiatric Hospital is a vocational program that prepares patients for work in the community in greenhouses, nurseries, and retail store garden centers such as Home Depot or Lowes.

Patients develop skills for the the skills set recommended by ONET Online, a national database which details skills needed for all occupations. Upon successfully completing the program, patients receive a certificate of completion which can be utilized when seeking a job in the community.

The garden center sells floral arrangements for Thanksgiving, Christmas, and other holidays at very reasonable prices. All you have to do is call to place your order and indicate your price point. They will tell you when your arrangement will be ready for pick-up.

This is a great program. They also sell gorgeous houseplants at a fraction of the cost of commercial vendors. They'll be happy to give you a tour any time they are open, which is M-Sat late morning and mid-afternoon. To place your order or to get more information call the greenhouse at 609-633-1898.
