City Ordinances

We've received reports of neighbors burning leaves and yard debris. Just a reminder to all Hiltonians that open burning *is prohibited* in the City of Trenton as per the NJ Administrative Code.

Also, I'm going to put a call into the City to find out what the plan is for removing all the debris on the streets of Hiltonia.

Section 7:27-2.3 - Open burning of refuse: (a) No person shall cause, suffer, allow or permit the disposal of rubbish, garbage, trade waste, buildings or structures by open burning. (b) No person shall cause, suffer, allow or permit the disposal of fallen leaves by open burning. (c) No person shall cause, suffer, allow or permit the disposal of any type of plant by open burning. (d) The provisions of this section shall not apply to open burning of refuse for training or research exercises in fire protection or prevention when conducted at a permanent facility or training center designed to be used solely for such purposes on a continuing basis.

N.J. Admin. Code § 7:27-2.3

They're Here! By Dennis Wendell

Our first backyard sighting of a cute little hopping insect coincided with a flurry of activity on the Hiltonia Google group alerting neighbors to the presence of the spotted lanternfly (Lycorma deliculata). We knew from news stories last summer that its presence was bad trouble. The Google group posts included excellent tips for protecting trees (e.g., reverse duct tape around the trunk), identifying egg masses (mud-like, usually on smooth surfaces), and spotting the pest's favorite host (Tree of Heaven, Ailanthus altissima).

Since then, the rise of the lanternfly in New Jersey has been covered in the New York Times (https://www.nytimes.com/2020/08/21/science/lanternbug-invasiveinsect.html?searchResultPosition=1), and the New Jersey Department of Agriculture included Mercer County in a quarantine designed to prevent the spread (https:// www.nj.gov/agriculture/news/press/2018/approved/press180731.html). Residents are urged to consult this checklist before moving outdoor items: https://www.state.nj.us/ agriculture/divisions/pi/pdf/NJResidenceSLFChecklist.pdf. Can you guess the amount of dead spotted lanternflies around this tree? This Ailanthus tree in Ewing township was made a "trap tree," by our Mercer County Park Stewardship staff, and what you see here is the result. Every female spotted lanternfly can lay two egg masses, which contain 30-50 eggs each. So for each dead female you see here, that's up to 100 fewer lanternflies next year!

- A follow-up session on Covid-19 with Mayor Reed Gusciora, where we discussed local statistics, the curfew, and reopening plans.
- A presentation by Rick Kavin and David McMillan from Mayor Gusciora's office about plans to bring an autonomous taxi transportation system to Trenton. This seems like a neat project with admirable goals (bringing safe and affordable transportation to residents). 

We've also resumed board and membership meetings in a virtual environment.

Heating Up By

More than just the temperature is heating up these days, the real estate market has been on fire.

Previously, I have written about tax issues and the 2017 Reval. The 2020 City tax rate has finally been set at \$5.535. To calculate your total 2020 tax multiply your assessment by \$.05535.

So after retiring from the Trenton Tax Assessor's office, I am now writing as a long time realtor. I have returned to listing and selling homes as part of an active, and I hope long, retirement - enough of having a "real job".



So, onto a summary of the real estate market in our own little world.

One of the most troubling factors, at least to me, is the vacant, foreclosed and "flips" that we are dealing with for the first time ever in Hiltonia.

The sold numbers run from the dismal mid \$100,000 for some of the bank foreclosures, through the \$200's and up to a tippy top of close to \$400,000. There are 4 homes currently for sale at \$198,900, \$250,000, \$259,900 and \$299,900. There is a home in Cadwalader Heights on the market at \$410,000 (which might be a little aggressive).

What can we do? Stay positive. Make sure our homes present a positive "curb appeal," then be aware and take responsibility for the problem homes that are occurring in our own little section of Hiltonia (I called the City this week about two of the vacant problem homes on my block). Any Hiltonian should call, email or report a concern online simply by utilizing govpilot.com on the City website or download the app for your phone.

So, we need to continue loving Hiltonia as a place not only where we live, where we are comfortable, and where our neighbors are also our friends.

City Hall Beat

Some recent developments from City Hall as submitted by Gary Lawery, Office of the Mayor:

- Mayor Gusciora announced a plan to develop new city services and commercial opportunities by purchasing the Westside Plaza at 215 North Hermitage Street as an alternative to the 2009 leasing agreement that costs the city over \$42,000 a month with no benefit to area residents. Link to release and related photos.
- Over the last couple of years, Trenton Public Works picked up over 3500 tires. Recently, we caught folks in a U-Haul suspected of trying to dump hundreds more at a site in North Trenton. - In response to Gov. Murphy's expansion of mail-in voting, Mayor Gusciora asked the Mercer County Board of Elections to add five additional secure drop boxes within Trenton in preparation for the upcoming general election on Nov. 3, 2020. The County Board of Elections agreed to provide the additional boxes. Link to the release.
- The City announced that it will consider proposals to deploy 5G small cell networks throughout the city, giving it a state-of-the-art internet infrastructure that will not only benefit Trenton residents, students, and small businesses, but also attract additional commercial opportunities as well. AT&T and Verizon will pay the city for each 5G small cell device they install and work with Trenton historians to ensure that important landmarks and historical properties are not disrupted by installations. Donna's Little Free Library By Pat Flores



It was June 3 when Christine Zeppenfeld sent me this photo of a female snapping turtle laying her eggs in a most unlikely place, a soft mound of dirt bordering the sidewalk along busy Stuyvesant Avenue.

Christine called NJ Fish and Wildlife Commission to report it and wondered about moving the eggs to a more secure location. She was advised to do nothing, because when the hatchlings emerge they have an instinctive sense of where to go and will head for the pond. She was also told the incubation is between 80-90 days.

Periodically we both walked to the turtle hatchery hoping that it had not been disturbed. Christine began checking daily from day 80 on and kept me informed.

DAY 84: HAPPY BIRTHDAY. I took my walk through the park and to the "mound" where I noticed there had been activity. Looking closely I could detect the surface of a small shell. I texted Christine: THEY'RE HATCHING! As it turned out, she had already been there and dashed home for her glasses.

So there we were, in the delivery room, midwife and assistant. Wow! This is huge!! But are they alive? Are more hatching? Further activity was so slow; we shuffled the dirt around a bit and found more that had broken through their soft shell but seemed trapped by all the dirt.

Forceps! We dug in. Gently lifting them out and placing on the ground, they quickly recovered and began running around. Bad news is they were running toward the street and not the pond. Good news is we created a Turtle Express, putting them all in a bag and carrying them to the water's edge.

Now, how to get them into the pond gently and without trauma? Aha! Christine took a large branch and one by one, lined up the 12 turtles. She slid the branch over the water. KERPLUNK! They entered the pond naturally. Then we shoved the branch into the water to provide a foothold, should they want something solid to climb on. Enjoy your beautiful new home; we'll be back to check on you!

Otherwise, you, as the resident, are responsible for bagging it all or transferring it to your trash cans. It CANNOT be left loose in the gutters before the defined collection dates. See page 9.

GovAlert is a great leap forward in moving City Hall towards greater community engagement, customer service and accountability. Whether you are seeing suspicious vehicles, drug deals, violations of zoning ordinances, disrepair to roads, pot holes, or ATVs, now we have a single, central contact to get our issues funneled to the appropriate city department (provided by Paulette Ayres, Civic Co-Chair).

Keeping Hiltonia Clean.... It's Up To Us!

Please keep in mind that the City does **NOT** pick up loose leaves from the gutters or curbside during the spring, summer, or early fall. Here is a synopsis of the "Leaf Collection Program" as issued by the City for **2019-2020**. The City has not yet published the schedule for **2020-2021** (we will post it to our website when it becomes available). Please use last year's collection program as a guideline for getting your leaves and debris ready for pick-up.

BAGGED LEAVES:

Beginning October 28, 2019 through December 27, 2019, bagged leaf collection will take place. Leaves may be placed curbside in plastic bags (preferably clear) or open rigid containers with handles. No more than 20 bags/containers can be placed curbside with weight not exceeding 50 pounds each. Place leaves at curbside the day after your normally scheduled garbage collection day. If collection day is Saturday, pick-up will be the next business day. Bagged leaves expedite collection and alleviates street flooding.

GUTTER LEAVES:

Loose leaves left at the gutter will be picked up October 21, 2019 through January 10, 2020 (last year's dates) according to the schedule. Due to Storm Water Management Regulations (N.J.A.C. 7:8), municipalities are required to follow strict guidelines for minimizing non-point source pollution; therefore, non-containerized leaves shall not be placed in the gutter more than seven (7) days prior to the scheduled pick-up date, and leaves must be ten (10) feet from storm drains. **PLEASE ADVISE LANDSCAPING CONTRACTORS OF THIS LAW TO AVOID PENALTIES AND FINES.****

** If you hire a lawn service, please make sure your service knows that they are responsible for hauling away any leaves or debris they collect outside of the guideline dates. Otherwise, you, as the resident, are responsible for bagging it all or transferring it to your trash cans. It CANNOT be left loose in the gutters before the defined collection dates.

BRUSH/BRANCHES:

Branches must be cut no longer than four (4) feet and twined in bundles not to exceed 35 pounds. Brush must also be twined into bundles. Brush/branches should be placed curbside separate from leaves. Leaves mixed with debris will not be collected. Inclement weather may necessitate changes to the collection schedule.

GRASS CLIPPINGS:

The City follows a policy of "Clip & Leave", which means when you cut your grass, you leave it to be absorbed back into the soil. For more information, please call the Solid Waste Office at (609) 989-3175.

If you let leaves and debris collect in the gutters, you are attracting rodents and other critters and also adding to the litter problem. We need to work together to keep our streets looking clean and well tended. Debris encourages drive-by littering as well. Let's show pride in our neighborhood by keeping the litter off our streets, curbs, and public spaces.
