Crime Prevention Tips Revisited By Ali Wilson

Editor's Note: We ran this very helpful article in 2018, but since we have so many new neighbors in Hiltonia, we thought it worth republishing. Lots of good advice offered. The advice lends well to your own home, too.

As some of you know, I work in the insurance industry. A couple of years ago I sent out an email regarding breaking and entering, and robbery of abandoned homes. The recommendations below came from risk engineers with whom I used to work:

- Periodically check on the house. Walk the perimeter; look for broken windows, doors that have been left ajar, or ladders leaning against the house. Peek inside and look for blankets, sleeping bags, or debris from food, which could be evidence of squatters.
- Mow the lawn and water the landscaping. In the case of foreclosed homes, the bank might hire someone to come out and do this, but abandoned homes in real estate limbo will typically be neglected.
- Install timers and motion sensors on any outdoor lights. Any floodlights that point in the direction of the vacant house should have timers and motion sensors. That way, potential thieves will have trouble planning an unseen break-in.
- Occasionally park your car in the driveway. If the house is bank-owned or on the market, you should call and ask permission before doing this, but a car in a driveway indicates that the house is occupied.
- Collect discarded mail and newspapers. An overflowing stand-alone mailbox or newspapers piling up on the porch mean only one thing: nobody is home. This is a huge red flag for any burglars or squatters in the area.
- Shovel and de-ice the driveway and sidewalks. Not only will this demonstrate that the property is taken care of, but it will also guard against any slips or falls.
- Put up signs. Alarm company signs or decals or even a "Beware of Dog" sign go a long way in deterring potential burglars and squatters. Remember to ask permission if the house is on the market or owned by the bank, however.
- Organize a community watch program. By gathering neighbors and asking them to volunteer their time, you can monitor the neighborhood and create plans for what to do in the event of a break-in or other emergency situation.
- Keep in mind that there are issues of liability if the true owner of the house would consider neighbors as trespassers. Nonetheless, it was strongly recommended that we organize an around-the-clock community watch program and well publicize it in the neighborhood and in the City. This will help to stem the tide of criminal behavior. We should continue to use email as an immediate communication tool about potential criminal activity.

Bordering Hiltonia is a NJ state institution that employs almost 1,300 people and cares for over 300 inpatients at a time. Trenton Psychiatric Hospital, founded in the 1840s by Dorthea Dix, continues to treat New Jersians with the most severe and persistent mental illnesses. The TPH staff address their mission through caring assessment, evidence-based treatment methods, and ongoing discharge planning.

Calendar year 2021 saw 195 persons admitted to TPH and 201 discharged. Despite pandemic-imposed limitations, holistic care has remained the highest priority through use of digital innovations and environmental adaptations.

In addition to ongoing assessment and individual and group therapy, TPH staff offer spiritual, rehabilitative and vocational services, along with nutritional and life skills training to their patients. These services and programs are available weekdays, evenings, and weekends.



A full cadre of hospital personnel, including food service, environmental and information management professionals, support the work of the treatment staff.

In future issues of *The Hilltone*, I hope to highlight some of the special programs offered to patients of TPH, including Social Skills Training, New Leaf Gardeners, Supported Employment, and others. As a member of the TPH Board of Trustees, I find it truly gratifying to interact with the dynamic, committed hospital staff.

A Very Important Date Is Coming Quickly - Election Day 2022 By Linda Reid

This is the first time the City of Trenton will hold its Municipal Election in conjunction with the nationwide election, on November 8th. So things will be a little different.

Hiltonians, and all city voters, will need to decide on the best choices for national, state, regional, and municipal representatives all at the same time. One of the reasons for this change was to save the expense of a separate election, but also to sync the voting for elected officials. Some believe it may also increase voter participation.

This year (and only this year) the terms for our City Council members will be for terms of staggered length. The four ward members will run for 2-year terms and the at-large members will be running for 4-year terms. The reason for this one-time event is so that going forward the City Council will have experienced members and then perhaps some newcomers. Elections bring new members to the council. In the past when voters have chosen mostly new members, it takes some time for all those newly elected to "learn the ropes."

So, while during this election day, we will be making decisions for all levels of government, the election of Mayor and the members of City Council will be the ones that most affect our day-to-day lives.

So, please take some time over the next few weeks to learn who is running for Mayor, West Ward and At-large council positions. The last day to file petitions to run was September 6 so now we know those who are seeking to represent us. As campaigning increases, and the candidates speak out, listen to what they are saying about their background, their experiences that qualify them for these very important positions, and the reasons why they think they will be effective leaders.

Remember this is not a popularity contest, they will be public servants. They need to work with the administration and listen to their constituents. Try to attend some of the debates, watch for "meet the candidates events," so you can see how these folks act in person (when they have to speak for themselves, and think on their feet).

And then choose those whom you believe will research, discuss, negotiate, and then decide how to best move the City of Trenton forward, while, at the same time, effectively spend our tax dollars. Those who are elected will need to work together, be civil to each other and to the public in order to get things done (very little has moved forward or smoothly in the last 4 years).

It's the Law - Rules and Regulations in the City Code That Help Preserve a Good Quality of Life By Lily Knezevich

You may not be aware that the City Code of Trenton prohibits certain activities in Hiltonia that would interfere with the quality of life and the beauty of our community. These ordinances range from building codes that regulate the kinds of structures that are permitted, to the maintenance of property, disposal of waste, the control of noise. Failure to abide by these rules can result in a citation and fines. Below are some of the ordinances that are important to our neighborhood, but not always observed consistently. Please take note. (Citations below are from the Code of the City of Trenton. https://ecode360.com)

Excessive Noise: Unnecessary, annoying noises are a nuisance and are prohibited.

Prohibited Noises (Chapter 167.1)

"It is hereby declared to be a nuisance and it shall be unlawful for any person to make, cause or suffer or permit to be made. . . any unnecessary noises or sounds by means of the human voice, or by any other means or methods which are physically annoying to persons, or which are so harsh or so prolonged or unnatural, or unusual in their use, time and place as to occasion physical discomfort, or which are injurious to the lives, health, peace and comfort of the inhabitants of the City. . ."

Types of prohibited noises (Chapter 167-2)

Included in the list of eleven categories of prohibited noises are playing devices at a volume that would disturb the peace, barking animals, vehicle noises, etc.

Burning Leaves: Burning leaves and yard waste is prohibited by NJ State Admin Code (Section 7.27-2.3). Open burning is also prohibited by the City Code §6.

Branches and Yard Waste: Must be bundled if it doesn't fit in trash cans or bags.

Branches and sticks need to be cut to lengths no longer than 4 ft. and tied in bundles (not to exceed 35 pounds each) for the City to pick them up. Those piles of debris are not just eyesores, but they attract critters. These piles seem to encourage others to litter as well. We've had an epidemic of piles of yard waste collecting in our streets in recent months and they are eyesores. Note that the Leaf Collection Program is for leaves only, not yard waste, and it only occurs during a few weeks late in the fall, usually November through early January. (See page 13 for further information. The dates will be announced on the City's website.) Please contact the City's Solid Waste Management Division at (609) 989-3175 or Street Division at (609) 989-3200 if you require more information.

§ 312-3 **Prohibited conduct; exceptions.**

"A. The owner or occupant of any property, or any employee or contractor of such owner or occupant engaged to provide lawn care or landscaping services, shall not sweep, rake, blow or otherwise place yard waste, unless the yard waste is containerized, in the street. If yard waste that is not containerized is placed in the street, the party responsible for placement of yard waste must remove the yard waste from the street or said party shall be deemed in violation of this chapter.

B. Exceptions. Areas scheduled for leaf collection through the Leaf Collection Program are exempt from the containerized yard waste ordinance, provided that the non-containerized yard waste placed at the curb or along the street is more than 10 feet away from any storm drain inlet. Additionally, non-containerized yard waste cannot be placed at the curb or along the street at any time prior to the scheduled pick-up date, except as described in the Leaf Collection Program."

Parking Commercial Vehicles, Trucks, Boats

The topic of what can be parked on the streets of Hiltonia comes up regularly. Below is the language of the ordinance:

§ 315-234 Exterior storage of vehicles, trucks and boats in residential zones

"A. Business vehicles. Vehicles which are used for business purposes may not be parked on any private property between the hours of 8:00 p.m. and 6:00 a.m., except in enclosed garages or behind the front building line.

Inoperable vehicles. Inoperable motor vehicles shall not be stored on private property for more than three weeks, except in enclosed garages.

Boats. Except for canoes and boats of under 20 feet in length, boats shall not be stored in the open for over one week, except within the rear yard at least three feet in distance from any adjoining property line."

§ 315-235 Trailers and recreational vehicles.

No automobile trailer or recreational vehicle shall be stored in the open for over one week, except within the rear yard, at least three feet from any adjoining property line."

The ordinances listed above capture important responsibilities of the homeowners and residents in Hiltonia, and fines can be issued if violations are reported. Please observe them to help preserve the appearance of our burg and our quality of life.




Hiltonia Book Club: The Gentleman from Moscow, by Terri O'Prey


Lily laid a beautiful foundation for our dishes, which of course were in the spirit of Russian cuisine.

How Were Hiltonia's Streets Named?



Was Hiltonia named for the rolling mounds above Trenton, or for the developer, Samuel Hilton?

"High above Trenton, it stands, on hills that are centuries old—and a veritable outdoor paradise. Adjoining beautiful Cadwalader Park on the west, no other spot around Trenton compares with Hiltonia. Years ago one of the far-sighted city fathers suggested that this land be added to the park. Now it is to become a place of beautiful homes. Here will be developed a private park community for people of refinement who enjoy the open spaces and abhor the noise and annoyances of life 'down town'.

Most interesting was a small Hiltonia booklet and city map printed in 1924. It was the best lead I could discover. That map had all the streets laid out and named, and building lots designated for each home construction. This, obviously, was Sam Hilton's design for the future.





I knew about the Trenton Research Room, which is at the downtown Trenton Public Library. Named the Trentoniana Room, it is headed by a very helpful and knowledgeable archivist, Laura Poll (open only by appointment). When I arrived Laura had books and folders, pamphlets, and other resources that pertained to Trenton, but only one small booklet on Hiltonia. That turned out to be the sole resource and is the reference quoted in the opening paragraph.

Jacques Lebel had inquired about the way the streets were named in Hiltonia. That answer remains a mystery. Via Laura's source material I discovered that people, places, states, seasons, and structures are often used in street names. I learned that most of Trenton's city streets were named for prominent Trenton families, but not so in Hiltonia.

I looked up SAM HILTON and discovered that he was born in England in 1883. He came to Trenton in 1902. He later moved to California and there learned about patio-style architecture, and the use of open spaces.

When he returned from California he acquired the land adjoining Cadwalader Park to develop a community of elegance. The first home was built in 1920.

Since none of our Hiltonia street names can be traced to any known person, place or thing, I am "assuming" that Hilton chose names meaningful to the memory of his native country, England.

ADDENDUM:

This information about Trenton streets was in the source material provided by Laura at the library.

Cadwalader Drive: Street and park named for the Cadwalader family, whose members had extensive holdings in the western section of the city. Dr. Thomas Cadwalader was the First Chief Burgess operating under a charter granted by King George II. He founded a public library in 1750.

Stuyvesant Avenue: Probably named for Peter Stuyvesant, last and most worthy of the Dutch directors of New Amsterdam.

Sullivan Way: Perpetuates the name of General John Sullivan, who commanded one of two divisions at the Battle of Trenton.

Sanhican Drive: Named for the Sanhican Indians, a branch of the Lenni Lenape, who lived where Trenton now stands. Their settlement was also know as Sanhican.

From the Archives (Sort Of) By Terri O'Prey

For some reason a "republish me!" article failed to catch my eye while flipping through old Hilltones for this issue. What did jump out, though, were recurring themes that continue to resurface in Hiltonia. The top two were reminders to mind and clean up after our dogs and the need to comply with yard waste and brush disposal ordinances. There are other repeated topics, of course, but these two populate our neighborhood newsletter consistently from its early days to now. I think they struck me because they call to mind a common shared goal: to make our neighborhood clean and safe for all.

The collective civic spirit of Hiltonia is strong. Our neighbors care deeply about their homes, sidewalks, streets, parks, and city. We care about each other. And one example of that spirit is a spot many of us pass daily: the Don Wallar Memorial Garden on the Hilvista lawn at Buckingham Avenue. As any local gardener knows, it's a challenge to keep beds beautiful in the face of roaming herds of intrepid deer. In the recent past, the Wallar garden has received only spare attention, with annual cleanups funded by the Hiltonia Association and carried out via neighborhood lawn service companies. It really could use some TLC and mindful thinning and planting to restore it to a pleasant spot to sit and reflect. Similar efforts are part of Hiltonia's heritage and, while I couldn't locate any Hilltone articles on the topic, Linda Reid was able to dig up a 2016 Google group posting from Bill Merz:

I just wanted to let everyone know (in case you did not already see) that clean up work has been completed at the Hiltonia Don Wallar Memorial Garden at the bottom of Buckingham Ave at Hilvista Blvd. Please stop and take a look as you drive by as it looks wonderful. At this time, it's only populated with daffodils; but soon we will plant many varieties of flowers. Traditionally, we try to populate the garden with plants and flowers from others who have gardens in the neighborhood. In past years, we've had much success in doing so. We won't be planting until the last snow and frost are behind us; but I thought that I would get the word out there that we are looking for controllable plants and flowers that are deer hostile or at least deer resistant that we can plant. (it actually gives me great pleasure to see hungry, perplexed deer staring at a garden full of beautiful munchies that they refuse to munch). Unfortunately, the last time that I headed the garden restoration, the deer got the last laugh, not by eating the garden, but by literally sleeping in and on it. Hopefully, this year we can add things that are unpalatable to eat AND sleep on. So, if you have any plants that are in these parameters, and you would like to donate clones, bulbs, cuttings, etc to the cause, please contact me and we will make arrangements to pick them up as we get closer to planting time. In the past, I've sent out a list of plants that the deer do not typically eat and I'll see if I can find it and send it out again to help with your own personal gardens. In addition, our Crepe Myrtle plant near the bench has completely died, so we are looking for a well manicured, controllable specimen to replace it (something other than Crepe Myrtle).

In addition to planting, my vision is to recondition or replace the garden bench; and I've already spoken to Leon Rainbow and Dean Innocenzi (Ras) about possible painting a mural on the bench; but before we do that, we will need to scrape it and put a base coat on it. We may even have to recondition the slats, so anyone who lives in the neighborhood that owns or works for a painting company, please feel free to contact me and maybe we can use you to get some of the preliminary work out of the way so that we can do something artistic to the bench. Incidentally, this bench was initially installed to commemorate the wonderful work of Jean Harbach who selflessly served this neighborhood throughout her many years as a resident of Hiltonia, so I'd like to make it special. Anyone who would like to help us plant when the time comes, please contact me and I'll keep you up to date on our progress. Thanks and have a wonderful weekend!

Don was a beloved longtime resident of the neighborhood, remembered well for his civic engagement and participation in Trenton's annual Heritage Days. As part of our continued efforts to keep our streets and sidewalks clean, we have the opportunity to revive the collective tending of the Don Wallar Memorial Garden. Interested in participating? Let me or another member of the Association's executive committee know.

The official name of the "Trenton Makes" Bridge is actually the Lower Trenton Bridge. In 1935, the words "TRENTON MAKES, THE WORLD TAKES" were installed on the south-facing side of the bridge. Coined by S. Roy Heath in 1910 as the slogan for the City of Trenton, the phrase represented the pride felt by the citizens of Trenton, a major manufacturing center for china, rubber, wire rope, and cigars at the time.

- Just a reminder to keep our streets clear on Wednesdays to ensure that the street sweeper can do a thorough job of cleaning our streets.
- If you hire a lawn service, please make sure your service knows it's responsible for hauling away any leaves or debris collected outside of City pickup dates. Otherwise, you, as the resident, are responsible for bagging it all or transferring it to your trash cans. It CANNOT be left loose in the gutters before the defined collection dates.
- times when in public. IT'S THE LAW! A dog can and will be impounded if found running loose in Trenton. If you suspect your pet is at the shelter, contact them at 609-989-3254, or email a picture and contact information to: jmunoz@trentonnj.org. Animals that are not reclaimed within a 7-day impound period become the property of the city. Owners reclaiming their pets will be charged a redemption fee based on the number of days your pet is housed and the services it receives. Redemption fees are accepted in cash or money order only.

Keeping Hiltonia Clean.... It's Up To Us!

Please keep in mind that the City does **NOT** pick up loose leaves from the gutters or curbside during the spring, summer, or early fall. Here is a synopsis of the "Leaf Collection Program" as issued by the City for **2021-2022**. The City has not yet published the schedule for **2022-2023** (we will post it to our website when it becomes available). Please use last year's collection program as a guideline for getting your leaves and debris ready for pick-up.

BAGGED LEAVES:

Beginning late October through late December, bagged leaf collection will take place. Leaves may be placed curbside in plastic bags (preferably clear) or open rigid containers with handles. No more than 20 bags/containers can be placed curbside with weight not exceeding 50 pounds each. Place leaves at curbside the day after your normally scheduled garbage collection day. If collection day is Saturday, pick-up will be the next business day. Bagged leaves expedite collection and alleviates street flooding.

GUTTER LEAVES:

Loose leaves left at the gutter will be picked up October through January according to the schedule. Due to Storm Water Management Regulations (N.J.A.C. 7:8), municipalities are required to follow strict guidelines for minimizing non-point source pollution; therefore, non-containerized leaves shall not be placed in the gutter more than seven (7) days prior to the scheduled pick-up date, and leaves must be ten (10) feet from storm drains. **PLEASE ADVISE LANDSCAPING CONTRACTORS OF THIS LAW TO AVOID PENALTIES AND FINES.****

** If you hire a lawn service, please make sure your service knows that they are responsible for hauling away any leaves or debris they collect outside of the guideline dates. Otherwise, you, as the resident, are responsible for bagging it all or transferring it to your trash cans. It CANNOT be left loose in the gutters before the defined collection dates.

BRUSH/BRANCHES:

Branches must be cut no longer than four (4) feet and twined in bundles not to exceed 35 pounds. Brush must also be twined into bundles. Brush/branches should be placed curbside separate from leaves. Leaves mixed with debris will not be collected. Inclement weather may necessitate changes to the collection schedule. Citations can be issued for those who do not comply.

Please contact the City's Solid Waste Management Division at (609) 989-3175 or Street Division at (609) 989-3200 if you require more information.

GRASS CLIPPINGS:

The City follows a policy of "Clip & Leave", which means when you cut your grass, you leave it to be absorbed back into the soil. For more information, please call the Solid Waste Office at (609) 989-3175.

If you let leaves and debris collect in the gutters, you are attracting rodents and other critters and also adding to the litter problem. We need to work together to keep our streets looking clean and well tended. Debris encourages drive-by littering as well. Let's show pride in our neighborhood by keeping the litter off our streets, curbs, and public spaces.
